In compliance with the Notice, the Company clarifies that, after the period of lower trading volumes due to the COVID-19 pandemic in the country, the trading volume for the Company's shares has increased, notably after the renegotiation of its debentures and the announcement of the intention to raise funds through a private capital increase or public share offering, as disclosed in the Material Fact released on June 20, 2020. To a certain extent, the trading activity for the Company's shares also followed the recovery curve of the Ibovespa Index over the past month.

The Company emphasizes, however, that it is not aware of any fact that could justify the variations in the trading volume of its shares on July 1, 2020, as highlighted in the table.

We reaffirm our commitment to continue to provide, in a timely and equitable manner, relevant and appropriate information to its shareholders and the market in general, pursuant to the terms of applicable regulations.
