In this regard, the Company clarifies that yesterday, before the opening of the trading session, its results and Financial Statements for the fiscal year 2020 were disclosed, which might have

relation with the oscillation observed on the same date. Additionally, we note that the parameters recorded in the previous days mostly followed the positive and negative variations of the IBrX 100 index, whose portfolio includes the Company's shares, and the Ibovespa index. The Company is not aware of any other specific fact that would be able to justify oscillation in trading of its shares.

The Company reaffirms its commitment to keep its shareholders and the market in general informed in a timely and equitable manner, in accordance with applicable legislation and regulations.
