In order to fill the vacant positions, the Board of Directors elected Mrs. Maristela Aparecida do Nascimento as Administrative and Financial Officer, and Mr. Vitor Alaga Pini for the position of Investor Relations Officer.

Mrs. Maristela Aparecida do Nascimento holds a degree in Business Administration and Accounting Sciences and an MBA in Finance from Insper - Instituto de Ensino e Pesquisa. She developed her career at Deloitte Touche Tohmatsu, where she worked for more than 5 years as an auditor. She has worked in the Company since 2013 as head of the controlling department.

Mr. Vitor Alaga Pini has been in the Company's investor relations department since 2016. Vitor holds a degree in Economics from the University of São Paulo. Prior to joining IMC, he worked at the Private Equity Fund Patria Investimentos and at publicly traded companies from the education sector Kroton and Anhanguera in the Investor Relations and Financial Planning departments. Vitor also has more than 8 years of experience in the capital markets acting as sell-side equity research analyst at Bradesco BBI and BBVA.

Lastly, Mr. Fabiano Artur Macalos Strelow was also elected as Director without specific designation.

Mr. Fabiano Strelow holds a bachelor's degree in Business Administration from the University of Caxias do Sul and an MBA in Business Administration from FGV-SP. Mr. Strelow has worked in the Company since 2016, and has solid experience in franchising and retail management and services, planning (R&D), identification and capture of new sites (market development), and restructuring operations. Fabiano has also worked as Director in shopping centers (JHSF), opening large operations in the greenfield model, in addition to having international experience in large companies that are leaders in their segments, such as Anhanguera, Burger King and GPA.
