Re.: Notice of Revocation of Tender Offer

Dear Sirs,

Reference is made to the voluntary tender offer ("Tender Offer") launched by Abanzai Representações S.A. ("Abanzai") for the acquisition of, at least, 69,000,000 (sixty-nine million) and a maximum of 69,375,000 (sixty-nine million three hundred and seventy-five thousand) common shares issued by International Meal Company Alimentação S.A. ("IMC" or "Company"), under the terms of the Tender Offer Notice published on November 19, 2018 and amended on November 29, 2018 and December 12, 2018 ("Tender Offer Notice").

Abanzai informs that (as provided in item 2.6 (xvi) of the Tender Offer Notice) it does not waive the condition referred to therein and, therefore, **will not continue with the Tender Offer**, in view of the approval, on December 13, 2018, of the amendment to the Bylaws of Company to include a provision that aims to oblige Abanzai, as a result of the Tender Offer, to launch a public tender offer for the acquisition of all shares issued by the Company.

Thus, the Tender Offer is revoked, in an unconditional, irrevocable and irreversible manner, ceasing to have any effects and validity, no longer being binding nor subsisting any obligation upon Abanzai or Brasil Plural Corretora de Câmbio, Títulos e Valores Mobiliários S.A., the Tender Offer's intermediary institution.

The Tender Offer's Auction, initially scheduled for December 19, 2018, will not occur.

We request IMC to disclose this letter to its shareholders and to the market in general by means of a notice of material fact.

Abanzai informs that it will continue to adopt measures that add value to the Sapore Group, its partners, suppliers and customers, which includes the search for new opportunities for organic and inorganic growth, including through acquisitions.
